# SUMMARY ANNUAL REPORT FOR

#### AGC-INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 701 HEALTH AND WELFARE TRUST FUND

This is the summary annual report for the AGC-International Union of Operating Engineers Local 701 Health and Welfare Trust Fund, EIN 93-6022485, Plan Number 501, a medical, dental, vision, weekly disability income, life, and accidental death and dismemberment insurance welfare benefit plan, for the period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the AGC–International Union of Operating Engineers Local 701 Health and Welfare Trust Fund has committed itself to pay certain medical and all dental, vision, and weekly disability income claims incurred under the terms of the Plan.

#### **INSURANCE INFORMATION**

The Plan has contracts with **Kaiser Foundation Health Plan** to pay certain medical claims, with **LifeMap Assurance Company** to pay all life and accidental death and dismemberment claims incurred under the terms of the Plan, with **Willamette dental Group** to pay dental claims, with **Vision Service Plan** to pay vision claims, and with **Union Labor Insurance Company** to provide stop loss coverage. Total premiums paid during the Plan Year were **\$5,498,420**.

Because the contract with **LifeMap Assurance Company** is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the Plan Year ending **December 31, 2022**, the premiums paid under such "experience-rated" contracts were **\$106,528**, and the total of all benefit claims paid under these "experience-rated" contracts during the Plan Year was **\$70,240**.

### **BASIC FINANCIAL STATEMENT**

The value of Plan assets, after subtracting liabilities of the plan, was \$64,176,468 as of December 31, 2022, compared to \$66,033,055 as of January 1, 2022. During the year, the Plan experienced a decrease in its net assets of \$1,856,587. This decrease includes unrealized depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan Year, the Plan had total income of \$20,579,136, including employer contributions of \$32,608,222, participant contributions of \$191,867, realized losses of \$(395,426) from the sale of assets, losses from investments of \$(2,890,921), and other earnings of \$65,393. Plan expenses were \$31,435,723. These expenses included \$2,033,551 in administrative and operating expenses, and \$29,402,172 in benefits paid to participants and beneficiaries. (Administrative expenses include administration fees, investment fees, auditing fees, attorney fees, banking fees, consulting fees and miscellaneous expenses.)

The exclusion of the accumulated eligibility credits increased net assets reflected in this Summary Annual Report at December 31, 2022, by \$10,257,600.
