## SUMMARY ANNUAL REPORT FOR DEFINED CONTRIBUTION PLAN OF AGC-INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 701 PENSION TRUST FUND

## FOR YEAR ENDING DECEMBER 31, 2023

This is the summary annual report for the **Defined Contribution Plan of AGC-International Union of Operating Engineers Local 701 Pension Trust Fund, EIN 93-6075580, Plan number 002, for the period January 1, 2023 through December 31, 2023**. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **BASIC FINANCIAL STATEMENT**

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Total plan expenses were **\$7,372,433.** These included benefit payments of **\$7,048,766** and operating and administrative expenses of **\$323,667**. (Administrative expenses include administration fees, investment fees, auditing fees, attorney fees, banking fees, consulting fees and miscellaneous expenses.) A total of **4,822** persons were participants in or beneficiaries of the plan at the end of the plan year, although some may not have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$143,447,545 as of December 31, 2023, compared to \$122,901,832 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$20,545,713. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$27,918,146, including employer contributions of \$6,131,521, net earnings from investments of \$21,502,518, and other income of \$284,107.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying these portions of the report because these portions are furnished without charge.
