This is a summary of the annual report for the Defined Contribution Plan of the AGC-International Union of Operating Engineers Local 701 Pension Trust Fund, EIN 63-6075580, Plan No. 002, for period January 01, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by the Trust. Plan expenses were \$11,221,687. These expenses included \$332,775 in administrative expenses and \$10,888,912 in benefits paid to participants and beneficiaries. A total of 4,923 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$157,211,971 as of December 31, 2024, compared to \$143,447,545 as of December 31, 2023. During the plan year the plan experienced an increase in its net assets of \$13,764,426. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year. The plan had total income of \$24,986,113, including employer contributions of \$6,302,062, rollovers of \$28,292, net investment income of \$18,574,289, and other income of \$81,470.
