SUMMARY ANNUAL REPORT FOR DEFINED CONTRIBUTION PLAN OF AGC-INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 701 PENSION TRUST FUND

FOR YEAR ENDING DECEMBER 31, 2024

This is a summary of the annual report for the Defined Contribution Plan of the AGC-International Union of Operating Engineers Local 701 Pension Trust Fund, EIN 63-6075580, Plan No. 002, for period January 01, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by the Trust. Plan expenses were \$11,221,687. These expenses included \$332,775 in administrative expenses and \$10,888,912 in benefits paid to participants and beneficiaries. A total of 4,923 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$157,211,971 as of December 31, 2024, compared to \$143,447,545 as of December 31, 2023. During the plan year the plan experienced an increase in its net assets of \$13,764,426. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year. The plan had total income of \$24,986,113, including employer contributions of \$6,302,062, rollovers of \$28,292, net investment income of \$18,574,289, and other income of \$81,470.

2. financial information and information on payments to service providers;
3. assets held for investment; and
4. insurance information, including sales commissions paid by insurance carriers.

The charge to cover copying costs will be \$5 for the full annual report, or .25 cents per page for any part thereof.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 7525 SE 24th STREET, SUITE 200, MERCER ISLAND, WA 98040, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
